According to the National Insurance Crime Bureau, nearly 1,000 pieces of equipment are stolen each month, with more than half of those thefts occurring on remote job sites. Equipment theft costs businesses over \$400 million a year; an individual business can face a loss of more than \$46,000 with a single theft. With the rising costs of replacing stolen assets, it's even more concerning that only 23 percent of stolen equipment is ever recovered by law enforcement.
